SUTTER ENERGY CENTER PETITION TO AMEND (97-AFC-2C) DATA REQUESTS

Background:

The U.S. Fish and Wildlife Service has issued new guidance (Pagel et al 2010, Interim Golden Eagle Inventory and Monitoring Protocols) on golden eagle nest avoidance since the Sutter Energy Project was licensed. Staff needs information on the presence of golden eagle territories in the project area in order to complete a discussion of LORS that are new or changed since the original project licensing.

Data request:

8. Please provide staff data on the occurrence of golden eagle nests within a 10-mile radius of the project site. Include resource database searches, consultation with local agencies, birding groups, museum records, and any other data sources that provide info on the occurrence of eagle nests in the project area. Also, please provide staff an analysis on the potential for indirect impacts to nesting golden eagles during construction, if nests occur in a 10-mile radius.
