Subject: Electricity Resource Plans (Docket No. 11-IEP-1B) Data Resubmittal for the California Energy Commission's (CEC) 2011 Integrated Energy Policy Report (IEPR)

Based on input received from the CEC staff, enclosed are the updated S1, S2, and S5 forms with the following changes:

- The Castaic Upgrades were added in Line 14d of the S1 form and line 10d of the S2 form.
- Unspecified geothermal and wind resources are now labeled as 'Generic.'
- Confidentiality labels across the S1 and S2 forms were removed because they were deemed unnecessary.
- Generic Resources were summed in line 25 of the S1 form and line 21 of the S2 form.
- Footnotes for both the S1 and S2 forms were updated.
- All unnecessary highlights in forms S1 and S2 were removed.
- Confidential Contract G is no longer listed as confidential.
- Footnotes for Confidential Contracts H, I, J, and K were updated.
- Solar_DWP_Owens, Solar_DWP_Basin and Pine Canyon are listed as *Utility-Controlled Renewable Capacity*.
- Milford 1 is now listed under *Total Capacity from Renewable Energy Contracts*.
