NOTICE OF RECEIPT
REQUEST TO TERMINATE ENERGY COMMISSION CERTIFICATION
for the
EAST ALTAMONT ENERGY CENTER POWER PLANT PROJECT (01-AFC-4C)

On March 23, 2011, Calpine Corporation filed a request with the California Energy Commission requesting the Certification be terminated for the East Altamont Energy Center Power Plant. The proposed natural-gas-fired, combined-cycle generating facility included a 230-kilovolt (kV) switchyard and approximately 0.5 miles of new 230-kV transmission lines.

The applicant's proposed site lies within a 174-acre parcel of land under the applicant's control, located in unincorporated Alameda County, approximately one-mile west of the San Joaquin County line and 1.0 mile southeast of the Contra Costa County line. The site is bordered by Byron Bethany Road to the north, Kelso Road to the south, and Mountain House Road to the west.

DESCRIPTION OF PETITION

The request would terminate the Energy Commission's Certification and the project would not be built.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this request on environmental quality, public health, and safety. Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving or denying the request will be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.
