PETITION TO AMEND
THE ENERGY COMMISSION DECISION for the
STARWOOD POWER PROJECT (06-AFC-10C)**

On July 11, 2011, Starwood Power-Midway, LLC, filed a petition with the California Energy Commission requesting to modify the Starwood Power Project. The 120-megawatt simple cycle electric generating station, certified by the Energy Commission on January 16, 2008, received a certificate of occupancy on August 27, 2009. The facility is located on 5.6 acres in an unincorporated area of western Fresno County, approximately 15 miles southwest of the City of Mendota

DESCRIPTION OF PROPOSED MODIFICATION

The modification proposed in the petition would change the limits for NOx emissions during start-up of each turbine. The proposed modification would have a direct impact on the total daily and annual emissions, affecting Air Quality Conditions of Certification, both those conditions specific to the daily and annual limits, and other air quality conditions to maintain consistency with the actual operating mode of the facility.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality, public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and, if the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, Calif. Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving or denying the amendment proposal will be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.
