Recently acquired by The IAPMO Group, the goal of Green *Plumbers* Training and Accreditation is to train and deploy thousands of residential and commercial "green" plumbers to promote the benefits of water conservation and the reduction of GHG emissions. The focus is on changing consumer and plumbing behavior through the use of energy efficient and water-saving technologies. Green *Plumbers* works with the plumbing industry, building officials, utilities and water agencies to implement the Green *Plumbers* program. The training consists of a five-part accreditation in environmental and technical issues including Caring for our Water, Climate Care, Water Efficient Technology, Solar Hot Water and an Inspection Report Service.

Green *Plumbers* Training & Accreditation wishes to enter into a California Partnership Academy support network, on a statewide basis to further the educational needs of students and the California Department of Education in promoting SBX1 1, Clean Technology and Renewable Energy Academies.

The new Certificate programs will be tied to the President's Better Buildings Initiative (BBI) and the High Performance Sustainable Buildings (HPSB) movement that both call for significant water efficiency mandates in the coming decade.

All of these new water efficiency educational initiatives, while geared primarily to drive water efficiency are also created to develop new career paths into the myriad of jobs that exist in the water industry.
