Pursuant to California Code of Regulations, Title 20, § 1231 which authorizes any person to file a request for investigation, I request the California Energy Commission investigate BNSF Railway Company's allegation the "Applicant's application and supplemental documentation contained material false statements regarding the commercial viability and availability of SunCatchers for the Calico Solar Project." (BNSF Railway Company Verified Complaint to Revoke Certification, p. 2 (Complaint))

BNSF's allegation is based on Section 25534(a)(1) of the Public Resources Code which states:

The commission may, after one or more hearings, amend the conditions of, or revoke the certification for, any facility for any of the following reasons:

(1) Any material false statement set forth in the application, presented in proceedings of the commission, or included in supplemental documentation provided by the applicant.

On June 14, 2011, Chairman Robert Weisenmiller filed Service of Complaint and Scheduling Order (Order) relating to BNSF's Complaint. The Order directed staff to investigate allegations raised in the Complaint as to whether Calico significantly failed to comply with the terms and conditions of certification.
