Subject: PIO PICO ENERGY CENTER (11-AFC-1), STAFF'S 2<sup>nd</sup> PROPOSED REVISED SCHEDULE

Per the Committee's Scheduling Order dated May 24, 2011, staff is hereby notifying the Committee that certain developments are impacting the Committee's most recent adopted schedule for this case and therefore staff is hereby requesting the Committee to adopt a revised project schedule.

On July 20, 2011, the applicant notified the Committee that the applicant would be late in filing data responses to BIO-29 and BIO-30. On August 1, 2011, the applicant filed their data responses to BIO-29 and BIO-30 which they also supplemented with additional data responses filed on August 11, 2011.

On August 5, 2011, staff issued an additional 11 data requests in the technical area of air quality which revisited some of staff's previous data requests that were not responded to in sufficient detail. In addition, staff had found errors in some of the applicant's calculations and air modeling that resulted in the new data requests.

This week staff has also learned from the San Diego Air Pollution Control District that they have delayed the issuance of their Preliminary Determination of Compliance (PDOC) due to unanticipated staffing issues. The result is the PDOC will now be published sometime during the end of August 2011.

On August 8, 2011, staff issued a public notice of a staff workshop to be held on August 24, 2011. Staff is planning on resolving all outstanding issues during the workshop. Because each of the developments described above are impacting the current schedule, staff is now proposing to delay publication of the Preliminary Staff Assessment, by approximately 3 weeks. As a result, staff is requesting the Committee to adopt staff's Proposed Revised Schedule, attached here.
