

CEC staff has assembled legislative history public documents related to three legislative bills that have potential relevance to the legislative intent questions that the Siting Committee has requested briefing on (see Appendix to Order No. 11-0824-8 dated August 26, 2011, available at http://www.energy.ca.gov/sitingcases/solar_millennium_ridgecrest/notices/2011-08-26 Appendix to Order 11-0824-8.pdf). These include documents from CEC staff files that specifically relate to three bills: SB 1575, the original Warren-Alquist Act legislation enacted in 1974; SB 928, legislation in 1988 that changed several renewable energy provisions in the Act; and AB 446, which removed a number of sections, including some of the "grandfather" provisions, from the Act in 1994.

The legislative history documents are in the form of .pdf files, roughly grouped by document category and bill number. They can be accessed at <u>http://www.energy.ca.gov/reports/Warren-</u><u>Alquist_Act/history.html</u>, or by clicking on legislative history links that have been established on the California Energy Commission's page for the Warren-Alquist Act or the Ridgecrest Solar Power Project's documents page.

IMPORTANT NOTE: The documents posted on the web are limited to public documents related to the three bills that have been located in staff files, or obtained by staff from other sources. In providing these documents, CEC staff makes no guarantee that they are the entire legislative histories for the three bills or that they contain all legislative documents of potential relevance to the issues raised in the Ridgecrest proceedings. To the contrary, additional documents relating to the three bills (as well as other legislation amending the Warren-Alquist Act) are known to exist at the California State Archives, and additional documents might also be found at other libraries or locations.
