Thank you for your letter dated August 30, 2011, setting forth your concerns regarding the DyoCore turbine and the rebates under the Emerging Renewables Program (ERP). In your letter you clearly set forth your view of the facts, and request monetary relief from the Energy Commission.

As you probably know, this matter is now the subject of a Complaint filed by Energy Commission Staff against DyoCore, alleging that the output rating of the DyoCore turbine was grossly overstated by DyoCore. In accord with Energy Commission regulations, a committee of two commissioners, Commissioners Peterman and Boyd, has been appointed to conduct hearings about the allegations of the Complaint. I have been assigned as the Hearing Officer.

We are not in a position to comment on the factual claims you make in your letter because this matter is currently pending. You can become a party to the proceeding, and thus have the opportunity to present evidence supporting your position, by intervening in the case.
