# NOTICE OF CANCELLATION OF PREHEARING CONFERENCE

**PLEASE TAKE NOTICE** that the Committee designated to conduct proceedings on the Complaint against DyoCore, Inc. brought by Energy Commission staff has **CANCELLED** the Prehearing Conference scheduled for Monday, September 19, 2011.

All filing requirements set forth in the Notice of Prehearing Conference dated August 31, 2011 and the Order Granting Staff's Request for an extension of time to file assessment of answer are also cancelled. The Committee will re-schedule the Prehearing Conference shortly and will issue a new Notice of Prehearing Conference. The new Notice will establish a schedule for the filing of Prehearing Conference Statements and Staff's Assessment of the Answer to the Complaint.

On Friday, September 9, 2011, Complainant Energy Commission Staff filed an Amended Complaint. Energy Commission regulations require that the Amended Complaint be served upon the Respondent, interested persons, and persons who could be affected by the relief sought. In order to comply with this regulation, effect proper service, and give adequate notice of the prehearing conference, it was necessary to cancel the September 19, 2011 prehearing conference.



Service on the attorney representing Commission staff does not satisfy this requirement. This Proof of Service form is not appropriate for use when filing a document with the Chief Counsel under Title 20, sections 1231 (Complaint and Request for Investigation) or 2506 (Petition for

Inspection or Copying of Confidential Records). The Public Advisor can answer any questions related to filing under these sections.
