Solar energy systems installed on renovated, existing residential buildings shall be eligible for NSHP only when the building is permitted as a newly constructed building by the building a

I recently added another 6kw photo voltaics to my old existing house. I did get the rebate, although greatly reduced from the one I received in 2001. I am not sure what the word "renovated" means in this context, because the code uses words like alteration and addition and defines them very specifically. One interpretation of this statement above would exclude my house from this program.

If that is true, it would also exclude many more. That would be a shame in an economic climate where most industries could use a boost, not the hammer. Why not get as many people and buildings involved as possible? Most existing buildings could not possibly meet the current code. We are not talking about getting T24 credit towards compliance. We might be talking about just helping the average home owner with average house set themselves free from corporately controlled energy; but of course we know that PGE does not want that. I had to fight tooth and nail with them just to get my systems approved and on line with them, a completely unnecessary war, which I eventually won; but the country and its economy can ill afford such behavior.

Anyway, that is my 2 cents.
