Subject: PIO PICO ENERGY CENTER (11-AFC-1), STAFF'S 3rd PROPOSED REVISED SCHEDULE

Per the Committee's Scheduling Order dated May 24, 2011, staff is hereby notifying the Committee that certain developments are impacting the Committee's most recent adopted schedule for this case and therefore staff is hereby requesting that the Committee adopt a revised project schedule.

Consistent with the applicant's recent letter to the Committee, dated October 3, 2011, staff is aware the applicant is revising the project to increase the level of water treatment and modify its wastewater disposal methods. Staff has advised applicant as to the scope of environmental analysis that should be provided in applicant's submittal. Staff expects to receive applicant's formal submittal addressing the project modification on October 28, 2011.

The California Independent System Operator recently published its C1C2 Phase II Interconnection Study Report (Phase II Cluster Study) which considered impacts on the electrical transmission system from the proposed Pio Pico Energy Center (PPEC). The timing of the publication and availability of the Phase II Cluster Study was identified in staff's Issues Identification Report as a potential issue that could impact the project schedule, which has now happened. On September 30, 2011, after reviewing the Phase II Cluster Study, staff issued an additional 36 data requests (#72 and #73 with subsets a-r for each) related to the electrical transmission system upgrades that were identified in the Phase II Cluster Study as being triggered by the PPEC.

As noted in the applicant's letter, applicant is also remodeling the PPEC's potential impacts to air quality, as required by the San Diego Air Pollution Control District ("District"). The modeling effort must be completed before the District can issue its Preliminary Determination of Compliance ("PDOC"). Because issuance of the PDOC is a precursor to staff completing its air quality analysis, the ongoing modeling work is also delaying publication of the Preliminary Staff Assessment (PSA).

Because each of the developments described above are impacting the current schedule, staff is now proposing to delay publication of the PSA until the last week of December 2011. As a result, staff is requesting the Committee to adopt staff's Third Proposed Revised Schedule, attached here.
