PURPOSE

The purpose of the workshop is to allow staff, the applicant, interested agencies, and the public to discuss Data Responses Set 1A and Set 1B and Data Requests Set 1C and Set 1D related to several technical disciplines, potentially including: Alternatives, Biological Resources, Cultural Resources, Land Use, Socioeconomics, Visual Resources and Water Resources. Other technical areas of the project proposal may also be discussed as necessary.

BACKGROUND

On August 5, 2011, Hidden Hills Solar Holdings, LLC, submitted an Application for Certification (AFC) to construct and operate the Hidden Hills Solar Electric Generating System (HHSEGS). If approved, HHSEGS would be located on approximately 3,277 acres of privately owned land leased in Inyo County, California, immediately adjacent to the Nevada border. The proposed project site is approximately 8 miles southeast of Pahrump, Nevada, and approximately 45 miles northwest of Las Vegas, Nevada. On October 5, 2011 the Commission approved the Executive Director's recommendation that the AFC was deemed "Data Adequate" and commenced the Commission's 12-month facilities siting review process.

PROJECT DESCRIPTION

As proposed, HHSEGS would comprise two solar fields and associated facilities: the northern solar plant (Solar Plant 1) and the southern solar plant (Solar Plant 2). If approved as proposed each solar plant would generate 250 megawatts (MW), for a total net output of 500 MW. Solar Plant 1 would occupy approximately 1,483 acres (or 2.3 square miles), and Solar Plant 2 would occupy approximately 1,510 acres (or 2.4 square miles). Each solar plant is proposed to use heliostats—elevated mirrors guided by a tracking system mounted on a pylon—to focus the sun's rays on a solar receiver steam generator (SRSG) atop a 750-foot tall solar power tower near the center of each solar field.

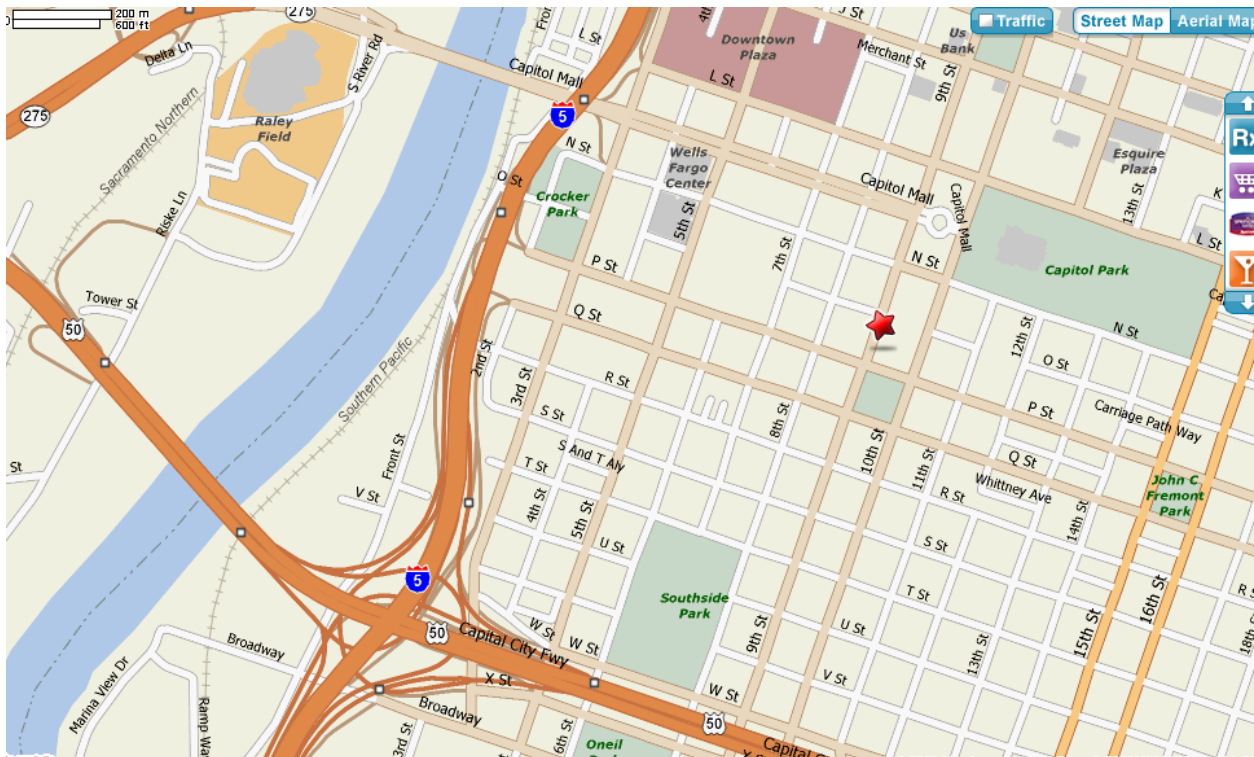
