You are receiving this letter because you submitted a rebate application to the Energy Commission's Emerging Renewables Program ("ERP") that identifies a small wind system that uses the DyoCore SolAir wind turbine ("DyoCore turbine") and received a corresponding Rebate Payment Claim Form ("R2 Form") from the Energy Commission for the system.

The Energy Commission recently concluded the DyoCore Complaint Proceeding by adopting an order that, among other things, states that the ERP will reimburse applicants who were issued R2 Forms for small wind systems that use the DyoCore turbine "for actual and provable costs that they have incurred" towards the installation of such systems ("Commission's Order"). Significantly, the Commission's Order provides that the total sum that can be paid out cannot exceed the rebate amount that was requested in your rebate reservation based on a rated output of 1.6 kilowatts ("kW") at 18 miles-per-hour wind speeds for the DyoCore turbine. The Commission's Order is available online at http://www.energy.ca.gov/renewables/emerging_renewables/11-cai-03/notices/2011-11-02_commission_adoption_order.pdf.

In order to submit a request for reimbursement under the Commission's Order, you must provide proof of costs incurred by you for the purchase and installation of your small wind system that uses the DyoCore turbine. Acceptable forms of proof for costs incurred include paid invoices signed by the customer and retailer, building permit receipts, canceled checks, and bank statements.

The Commission's Order also requires applicants seeking reimbursement to "execute a release agreement that releases all claims against the Energy Commission and KEMA, Inc. arising from the applicant's involvement in the ERP." The standard release agreement that has been prepared for all consumers holding R2 Forms for small wind systems that use the DyoCore turbine is enclosed with this letter ("Release Agreement").

After Energy Commission Staff ("Staff") have reviewed your request for reimbursement, including all supporting documentation, and determined the appropriate payment amount, Staff will provide you with an individualized Release Agreement that identifies your name and the payment amount that you may receive. In order to receive reimbursement under the Commission's Order, the individualized Release Agreement must ultimately be signed by you and returned to the Energy Commission.

In order to expedite Staff's review, requests for reimbursement and supporting documentation should be submitted to the Energy Commission by February 1, 2012.
