The California Energy Commission (Energy Commission) will hold a public hearing for consideration and possible adoption of proposed amendments to the Appliance Efficiency Regulations, contained in Sections 1601–1608 of Title 20 of the California Code of Regulations (CCR). The purpose of this rulemaking is to adopt efficiency standards, certification and marking requirements for large and small battery charger systems, and to adopt self-contained lighting control standards from Title 24 of the CCR to ensure that only self-contained lighting controls that comply with applicable standards are sold or offered for sale in California. The Energy Commission has also drafted a proposed Negative Declaration regarding the amendments, which will also be considered and possibly adopted at the same public hearing.

## **BACKGROUND**

On October 7, 2011, the Office of Administrative Law published a Notice of Proposed Action (NOPA) concerning the potential adoption of proposed amendments to the Appliance Efficiency Regulations (Express Terms or 45-Day Language). The NOPA and 45-Day Language were also posted on the Energy Commission's website on October 7. On October 11, 2011, the Energy Commission published and posted on its website a Notice of Availability and Hearing for the Initial Study and Proposed Negative Declaration for the proposed amendments. The first public hearing listed in the NOPA, with the Energy Commission's Efficiency Committee, was held on October 24, 2011, where public comments were received. The 30-day comment period for the proposed Negative Declaration ended on November 10, 2011, and the 45-day comment period for the proposed amendments ended on November 21, 2011. On November 23, 2011, the Energy Commission published and posted on its website a Notice of Postponement, notifying the public that the November 30, 2011, hearing date contained in the NOPA for consideration and adoption of the amendments and the Negative Declaration had been postponed to a date to be announced. The Notice of Postponement noted that additional time was needed to review and consider comments received during the 45-

day comment period, and to determine whether changes to the proposed amendments (by way of 15-Day Language) were warranted.

## **PROPOSED 15-DAY LANGUAGE**

The proposed amendments to the Express Terms (15-Day Language) are available on the Energy Commission website, under “Documents Page for Phase II on Appliance Efficiency Regulations Rulemaking, Docket # 11-AAER-2, Rulemaking Documents, Express Terms – 15-Day Language,” posted on December 14, 2011, at: [http://www.energy.ca.gov/appliances/battery\\_chargers/documents/](http://www.energy.ca.gov/appliances/battery_chargers/documents/)

The 15-Day Language changes to the originally-proposed 45-Day Language are indicated by double strikethrough (~~example~~) for deleted language and double underline (example) for added language. The 15-Day Language changes include:

1. Clarifying language for self-contained lighting controls and battery charger systems;
2. All January 1, 2013 compliance dates have been changed to February 1, 2013;
3. Allows battery charger system manufacturers to choose to between marking the product or labeling the product’s packaging; and
4. Allows an additional one year for compliance with the applicable standards for USB charger systems with a battery capacity of 20 watt-hours (Wh) or greater.
5. Additional added reporting requirements necessary to verify compliance.
