NOTICE OF PUBLIC INFORMATIONAL HEARING AND SITE VISIT

The California Energy Commission has exclusive jurisdiction to license new power plants that generate 50 megawatts (MW) or more. Under state law, power plants that generate up to 100 MW may be exempted from the Energy Commission's licensing process if the Energy Commission determines a project proposal qualifies for such an exemption. The Small Power Plant Exemption (SPPE) review process provides the public forum for the Energy Commission's evaluation of the project's eligibility for an exemption under Public Resources Code section 25541.

On November 18, 2011, Xeres Ventures, L.L.C., (Applicant) submitted an Application for a Small Power Plant Exemption (SPPE) to the Energy Commission in connection with its proposal to construct and operate the Santa Clara SC-1 Data Center, Phase 2, (Data Center), at 555 Reed Street, Santa Clara, California. Xeres proposes to install 16 diesel fueled backup generators at the Data Center in addition to the existing 16 permitted diesel fueled backup generators recently installed at the Data Center, located in an industrial area in the city of Santa Clara, Santa Clara County, California. Each backup generator has a capacity to generate 2,250 kW, or 2.25 MW.

BACKGROUND

On November 21, 2011, the Energy Commission began a review of the SPPE for the Santa Clara SC-1 Data Center under the provisions of Public Resources Code section 25541. During the review period, the Commission will determine whether construction or operation of the proposed project will create a substantial adverse impact upon the environment or energy resources. The Informational Hearing, as scheduled by this Notice, is sponsored by the Commission to inform the public about the project and to invite public participation in the review process.

PROJECT DESCRIPTION

The Data Center is an approximately 312,000 square foot building on a 16.1 acre site located on the north side of Reed Street, west of De La Cruz Boulevard, in the city of Santa Clara. The site was formerly developed as a lumber mill and is within a fully developed area in Santa Clara. The Data Center, which is two stories and approximately 48 feet in height, will house computer servers and supporting equipment for private clients, as well as associated office uses, in an environmentally controlled structure. Additionally, a substation and switchgear were installed on the site. The backup generators 17-32 for Phase 2 will be housed in a 51,550 square foot penthouse enclosure on the second floor of the Data Center and will be air cooled. The second floor will also contain 14,087 square feet of offices. The first floor will house mechanical equipment and computer servers.

The entire structure including all on-site civil improvements, central office, loading, and control/security areas, as well as sixteen backup generators have been constructed during Phase 1. Phase 2 will include the outfitting of all the remaining critical infrastructure, walls and partitions, raised floor and the remaining sixteen backup generators. An 80,000 square foot area in the northeast corner of the site will remain vacant (e.g., not covered by buildings or pavement). Commercial operation of Phase 1 began in September 2011.

Copies of the application were provided to local public agencies that are involved in the review process. Copies are also available at the Energy Commission's Library in Sacramento, the California State Library in Sacramento, and at California public libraries in Eureka, Fresno, San Francisco, Los Angeles, and San Diego. In addition, copies will be distributed to those public agencies that would normally have jurisdiction except for the Energy Commission's exclusive authority to certify sites and related facilities. Copies were provided to Santa Clara City Library, 2635 Homestead Road, Santa Clara, California 95051 and Santa Clara County Library, 77 Harrison Ave., Campbell, California 95008.

PURPOSE OF THE INFORMATIONAL HEARING

The SPPE process, which incorporates requirements equivalent to the Initial Study process under the California Environmental Quality Act, will examine whether the proposed project will create a substantial adverse impact upon the environment or energy resources. The review process provides a public forum allowing the Applicant, Energy Commission staff, governmental agencies, adjacent landowners, and members of the general public to consider whether the proposal qualifies for an exemption from the Commission's licensing process.

The Informational Hearing scheduled by this Notice is the first in a series of Energy Commission events where members of the community and governmental agencies will have an opportunity to obtain information and offer comments on the proposal. The Applicant will explain plans for developing the proposed site and related facilities. Energy Commission staff will explain the exemption process and its role in reviewing the application for exemption. Applicant and Staff will also discuss the schedule and possible issues that may be significant during this proceeding. The Commission's Public Adviser will provide information on how the public can participate in the review process.

PROPOSED SCHEDULES AND ISSUE IDENTIFICATION REPORT

To assist participants in understanding the project, Applicant and Commission staff shall each file a proposed schedule for conducting the exemption process, and Staff shall file an Issue Identification Report ("Report") summarizing any potential issues. The proposed schedules and Staff's Report shall be filed no later than **3 p.m., January 17, 2012**. At the Informational Hearing, the parties shall indicate whether anticipated data responses would resolve issues of concern which may be raised in Staff's Report. At the informal participation level, written and oral public comments are considered by the commissioners and are part of the record, but are not part of the formal evidentiary record. Intervenors have the right to introduce evidence into the evidentiary record and cross-examine the other parties' witnesses.

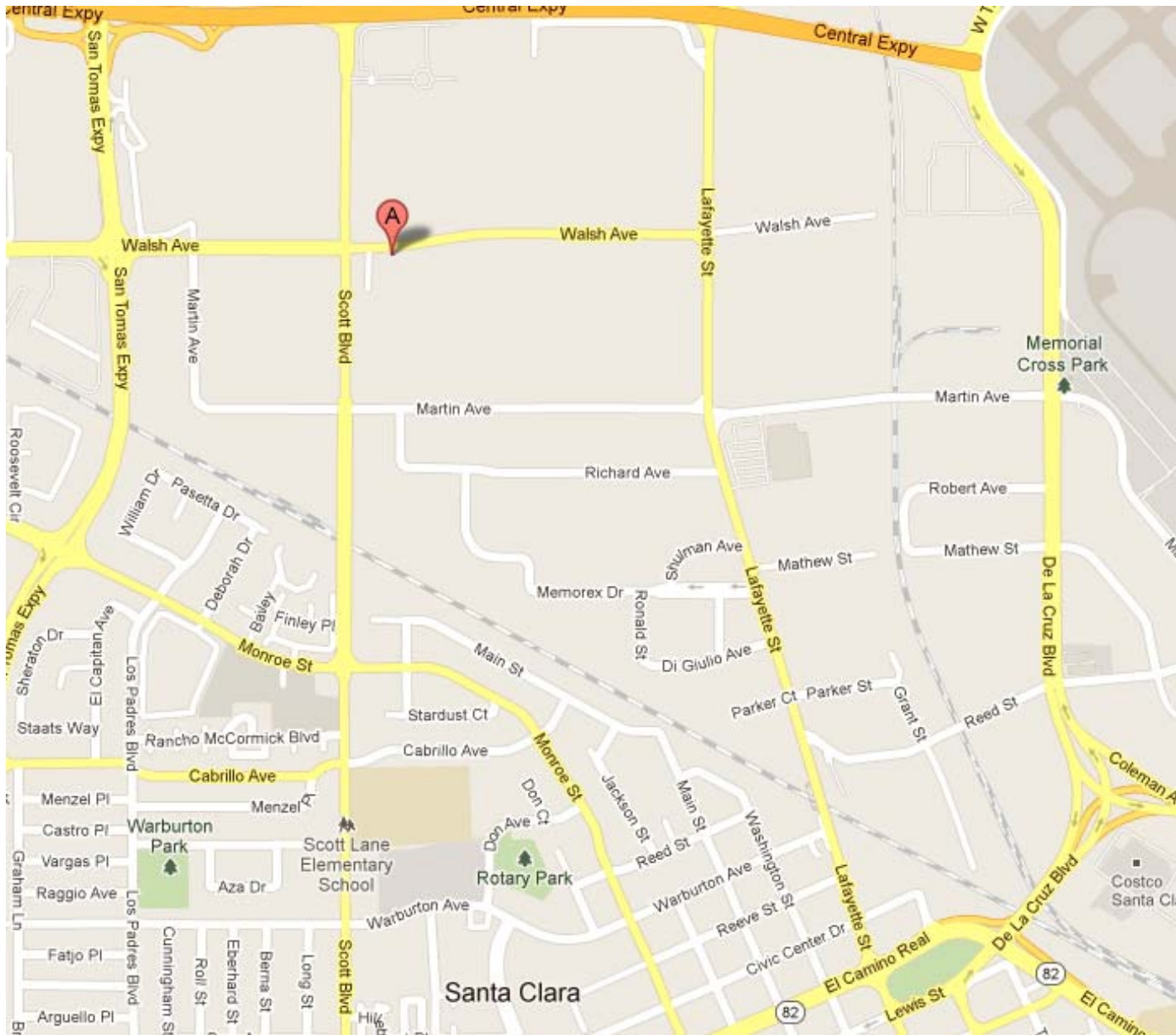
