Subject: GOSOLAR-LIST: Update on the Proposed Revisions to the New Solar Homes

Partnership Guidebook

As part of the January 12, 2012 Business Meeting, the Energy Commission will consider adopting revisions to the New Solar Homes Partnership (NSHP) Guidebook, Fourth Edition. A notice containing the proposed revisions and the draft fourth edition Guidebook were posted on the Energy Commission website on 12/14/11. After receiving and reviewing stakeholders' written comments to the proposed NSHP Guidebook, Fourth Edition, the following two proposed revisions have been removed and the applicable requirements will remain unchanged from the current NSHP Guidebook, Third Edition:

- A complete NSHP reservation package must be submitted prior to the issuance of a certificate of occupancy for that project. (Referenced on Page viii of the draft fourth edition Guidebook.)
- Removes the 180-day window between the issue date of a solar energy system permit and the issue date of a certificate of occupancy. A solar energy system permit must be applied for prior to the issuance of the certificate of occupancy. NSHP Program Administrators may request documentation verifying the application date of the solar energy system permit and the issue date of the certificate of occupancy. (Referenced on Pages viii, 13, 57, D-2 of the draft fourth edition Guidebook.)
