Pursuant to Section1716(f) of the Commission's regulations, Hidden Hills Solar I, LLC and Hidden Hills Solar II, LLC (collectively, the "Applicant") hereby files this notice regarding the need for additional time to respond to certain data requests issued by Staff on January 9, 2012.

Data Request 141 requests information regarding the "results of a pump test of sufficient duration and flow to demonstrate that the aquifer can provide a reliable supply for project construction and operation [and] provide sufficient data to evaluate whether any barriers to flow exist." In response to this data request, Applicant commissioned a pump test for the HHSEGS site, drafted a pump test plan, and provided the pump test plan to Staff and Inyo County for review and comment. On January 25, 2012, Staff and Inyo County provided their input on the pump test plan. Applicant is currently in the process of implementing the pump test plan; however, it is possible that the full results of the pump test will not be available in time to meet the deadline to respond to Staff's data request. Therefore, Applicant is providing notice that it may need until February 29, 2012 to respond to Data Request 141.
