Dear Mr. Jensen:

Data requests (Set 1D, #'s 97-135) were filed on December 6, 2011 in the technical areas of <u>Cultural Resources</u> (#'s 97-134), and <u>Waste Management</u> (# 135). As you know, on January 27, 2012 BrightSource Energy officially objected to several of the Cultural Resource data requests from Set 1D. Specifically, Applicant objected to Data Request #'s 105, 106, 108, and 125; partially objected to #'s101, 104, 109, 127, 129-131, and requested additional time to respond to #'s104, 115,116, 117, and 127. The objections were discussed at the January 18, 2012 Issues Resolution Workshop in Inyo County, and subsequently explained in more detail at the January 24, 2012 Hidden Hills Committee Status Conference.

Per Committee direction provided at the January 24, 2012 Status Conference, Cultural Resources staff from the Energy Commission and the Cultural Resources consultants for the Applicant engaged in an informal informational exchange session immediately following adjournment of the Committee Conference. As was directed when the Committee granted a 10-day extension of the January 26, 2012 Motion to Compel deadline during the Committee Conference, staff and applicant exchanged information related to the objected data requests in Set 1D. One result of the information exchange between staff and applicant was the mutual agreement that <u>Set 1D Data Requests #'s 109, 129, 130, 131 and 132 are no longer necessary, and that these data requests should officially be withdrawn.</u>

With the Committee's 10-day extension of the Motion to Compel deadline (until February 6, 2012), staff will continue to provide timely updates on resolution efforts related to Data Requests Set 1D.
