Purpose

This workshop is to understand the range of perspectives concerning 10-year energy demand forecasts. Energy Commission staff will present their revised 10-year forecasts of electricity demand and consumption, and, where appropriate, natural gas end-use consumption, including discussion of the methods, data, and assumptions used to develop those forecasts. Load serving Entities (LSEs) and other parties who wish to propose alternative demand forecasts or have questions on the assumptions and methods of the revised staff demand forecasts should use this workshop as their opportunity to contribute to the record of the proceeding.

Background

Energy Commission staff has developed forecasts of electricity and end-use natural gas consumption and peak electricity demand for each major utility planning area within California for the 10-year period, 2012-2022. These forecasts will be published in a staff report prior to the February 23, 2012 workshop. Staff conducted a workshop on August 30, 2011 to receive public comments on the staff preliminary forecast. Staff has revised the forecast to address many of the comments received, as well as direction from the IEPR Lead Commissioner. The revised demand forecasts are prepared using Energy Commission forecast methods; they are not dependent on any LSE forecast.

Following the workshop, the Lead Commissioner will provide direction to staff concerning any remaining revisions to demand forecasts. The final forecasts will be used in a number of applications, including the *2012 IEPR Update*, the CPUC's 2012 procurement process, and the Energy Commission's electricity supply-demand assessments. The final forecasts will also be an input to the California Independent System Operator's controlled grid studies, other transmission planning studies, and the California Gas Report.
