Sorry for the delayed response. See the exchange below. It appears they have not needed to contact the Sherriff at all. Since we have onsite security there has been no need to engage the Sherriff to date.

The closest emergency response for Ivanpah is in Jean, Nevada. There is a Las Vegas Metro, Nevada Highway patrol, and Ambulance/EMT services in Jean. This is where the emergency services come from for any medical emergency. They first contact The service in Jean then call San Bernardino to inform them there was an incident. Hope this helps.
