Dear Mr. Solorio,

I recently heard about the proposed Quail Brush Generation Plant the SDG&E is trying to build in Santee. This project would cause significant harm to both the community of Santee and the open-space preserves of Mission Trails and Sycamore Canyon.

Directly to the southwest of the proposed site is Mission Trails Park. Mission Trails Park is a one of the reasons I moved to San Diego. It has dozens of miles of hiking, biking, and horse riding trails that are used by countless residents and tourists every day. It is a true natural treasure to the people who live in and visit San Diego. Likewise, Sycamore Canyon, which directly borders the proposed site to the northeast, is a beautiful park that is used daily by hikers, bikers, and equestrians. In addition to the health and spiritual benefits that these two parks provide mankind, they also provide valuable natural habitat to many species of animals, including deer, coyotes, owls, jack rabbits, mountain lions, snakes, lizards, and even tarantulas.

To the south and southeast of the proposed site, is the community of Santee. In fact, one of Santee's most established neighborhoods and the high school that serves it is within 200 yards of the proposed site. Santee is a community that until recently, had been considered a rural community with few resources.
