Pursuant to Section 2505(a)(4), Title 20 of the California Code of Regulations, Rio Mesa Solar I, LLC, Rio Mesa Solar II, LLC, and Rio Mesa Solar III, LLC (collectively, the “Applicant”), hereby submits this “Repeated Application for Confidential Designation” for certain paleontological resources information for the Rio Mesa Solar Electric Generating Facility.

By letter dated October 31, 2011, the Executive Director approved the initial request for confidential designation regarding paleontological resources.
