

Dear Mr. Olivares:

In response to your March 2, 2012 email to Anne Runnalls, Sierra Research is pleased to provide the following information. Please note that effective immediately, Mr. Tom Andrews will serve as the air quality engineer and technical point of contact for the CPV Sentinel Energy Project. Tom can be reached at 916-444-6666 and <u>TAndrews@sierraresearch.com</u>.

The existing RECLAIM/Title V Facility Permit for the CPV Sentinel Energy Project includes an expiration date for the Permit to Construct that is included as part of the Facility Permit. The Facility Permit states that the Permit to Construct (PTC) shall expire one year from the PTC issuance date unless an extension is granted by the District (Section E, Condition 1.b). Since the PTC for the CPV Sentinel Energy Project was issued on April 15, 2011, the PTC will expire on April 15, 2012.

Over the past 12 months, construction at the project site has been on-going; enclosed is a summary of the construction activities that have occurred to date. While a significant amount of work has been performed at the site thus far, to allow sufficient time to complete all construction activities and cover the initial operation of the new permitted equipment at the facility, we request that the District issue an 18-month extension to the CPV Sentinel Energy Project PTC expiration date. The proposed new PTC expiration date would be October 15, 2013, which will enable the Applicant to complete construction, commissioning, and compliance testing for all of the units.
