Subject:

SDPC public meetings and the proposed Community Plan Amendment (CPA) to the East Elliot Community Plan District, for the purpose of siting the proposed Quail Brush Generation Project. The SDPC practice of restricting public comment on this matter "...to three (3) minutes **total per subject** regardless of the number of those wishing to speak..." (per SDPC Agenda item-1 March 15, 2012) is a violation of the Civil Liberties of the persons that would like to make public comment on the issue. This person respectfully requests the SDPC respect the Civil Liberties of each individual person that wishes to speak on the subject by providing the following: 1.
