## Purpose

The purpose of this workshop is to seek input from experts, stakeholders, and the general public on evaluating and capturing the benefits of renewable energy for California. The workshop will discuss recent assessments of public benefits of different types of renewable energy. The workshop will also discuss whether these benefits are sufficiently considered in renewable procurement programs or other related programs, and new ideas to better capture benefits of renewable energy for California.

The focus for this workshop is health and environmental benefits. Economic benefits will be included, but employment impacts will be discussed in more detail at a later workshop.

The lead commissioner will consider input from this workshop together with other information from the 2012 IEPR proceeding to develop strategies for quantifying and capturing additional public benefits for California in renewable procurement programs or other related programs.

## Background

This workshop is the first step in implementing the following overarching strategy recommended in *Renewable Power in California: Status and Issues* (CEC-150-2011-002-LCF, 2011) to guide California as it works to achieve its renewable energy goals: “Evaluate the cost of renewable energy projects beyond technology costs – including costs associated with integration, permitting, and interconnection – and their impact on retail electricity rates. This evaluation shall be coupled with a value assessment that could potentially lead to monetizing the various system and non-energy benefits attributable to renewable resources and technologies, particularly those benefits that enhance grid stability and reduce environmental and public health costs.” (p. 18-19).
