Gentlemen,

Cogentrix Energy, LLC, as the owner/developer for the proposed Quail Brush Power Project (QBPP), based upon our Power Purchase Agreement (PPA) discussions and negotiations with San Diego Gas and Electric Co. is proposing the following minor change to the method for calculating the permit limits for the Wartsila power cycle engines.

We understand that the draft permit is currently being developed and would like to request the facility limits be based on total mass emissions rather than annual hours of operation. In other words, we are requesting that no limits on annual operating hours be placed in the draft or final agency permits for each engine or for the facility in total, and that engine run hours be based on the proposed hourly, daily, and annual emissions limits. Additionally, we also propose the deletion of the annual fuel use limit on each engine and replace it with a facility wide annual fuel use limit (based on all 11 engines) Thus, we are not proposing a change to the total facility emission limits, but rather a change to the method for tracking compliance that does not use annual engine run hours or individual engine annual fuel use limits. Additionally, we may run some engines more, on an annual basis than others. We will incorporate this into the modeling assessment to insure that no violations to ambient air quality standards or increments would occur. To track compliance, the emissions from each engine will be tracked via the CEMs for NO<sub>x</sub> and CO, and with fuel use and emission factors for PM10/2.5, SO<sub>x</sub>, and VOCs.

This request is consistent with similar requests on power projects in California, where operational flexibility was granted with respect to run hours, based upon maintaining compliance with proposed hourly, daily, and annual emissions and fuel use limits. Previous projects which have utilized this approach are the Pio Pico Power Project, Roseville Energy Center Project, Oakley Generating Station Project, Russell City Energy Center Project, etc. As stated, the proposed change does not affect the current estimated or proposed facility hourly, daily, or annual emissions values, nor does it affect the proposed annual facility fuel use value as currently evaluated in the permit application.

The QBPP will track emissions and compliance with the applicable emissions limits from each engine, and the engines in total, as follows:

- NOx and CO CEMS, as currently proposed, will be installed on each engine stack, and will be used to track compliance for these pollutants.
- Source testing, coupled with dedicated fuel use meters on each engine, and periodic fuel sampling and analysis, will be used to track compliance for pollutants such as PM (PM10/2.5), SO2, and VOC.
- Individual engine runtimes will be monitored and tracked via the DAHS.

These proposed changes will result in allowing the plant to run more flexibly under the PPA, while at the same time maintaining compliance with the currently proposed emissions values and annual facility fuel use limits.
