

Pursuant to Section 2505(a)(4), Title 20 of the California Code of Regulations, Rio Mesa Solar I, LLC and Rio Mesa Solar II, LLC (collectively, the "Applicant"), hereby submits this "Repeated Application for Confidential Designation" for certain portions of the Power Purchase Agreement for the Rio Mesa Solar Electric Generating Facility.

By letter dated March 29, 2012, the Executive Director approved the initial request for confidential designation regarding certain portions of the Power Purchase Agreement. Applicant now wishes to submit in this repeated application confidential designation additional portions of the Power Purchase Agreement in response to CEC Staff Data Requests 170 and 171 from Staff's Data Requests Set 2A. In addition, On June 19th, 2012, Applicant filed a redacted version of its response to Data Request 170. Applicant redacted the portion of its response to Data Request 170 where it needed to discuss provisions of its Power Purchase Agreement. Applicant seeks confidential designation for the complete, un-redacted response to Data Request 170. This confidential filing is contained on five CDs. The information submitted with this repeated application is substantially similar to the information submitted in the Applicant's initial application, and all facts and circumstances relevant to the confidentiality of the information remain unchanged.
