Mr. Eric Solorio,

I am taking the time to express my deep opposition to this re-zoning and gross neglect of our natural resources. I understand the need for more energy as this area grows in population. However, we need to do it the right way. Not just the easiest way or the way that appears at first glance to "benefit the most people." We need to do this the right way the first time. We have an opportunity to set a standard for people to follow.

I desire further public studies into the air quality impact of the valley where El Cajon and Santee sit. If you have ever driven over there you probably have seen how the winds force the air to stay trapped in that valley and the poor air quality they already experience. It seems only logical to examine how a gas power plant would increase the pollution in that area.

I believe there are other more responsible ways to generate power for our homes and businesses. Gas plants might be the most profitable way to go, but we MUST consider the signal we are sending to our future generations. Most home owners would LOVE to have solar panels that supply surplus back into the grid. And San Siego is nearly the perfect place for that. Think of how many lives you could be impacting in a positive way instead of a potentially negative way.

I often run in Mission Trails Regional Park which is where I first heard about this today. I was out running and was approached with the information. MANY people, children, elderly, women, men, and even dogs utilize this park for getting some fresh air and exercise. It concerns me greatly to hear that the air quality will be impacted however slightly in this area. People spend enough time in congested areas of the city and they need a place to go to relax and get the stress from daily life off of them. Please use your position of authority to protect this natural resource. I invite you to come down and walk through the trails, and visit the visitor's center and see the dam constructed long ago.

In the long term, I believe this area will be harmed by the current plans of a gas plant. I believe that a select few will financially benefit in the short term at the expense of the majority in the long term. I believe we have the intelligence and God given responsibility to find a better way to use the resources He created. I believe we all be held accountable for our part in this action. Judgement will come. It may not be today, or in the next 10 years, but there will be a price to pay for us and our children if we make poor choices.

I realize that you face difficult challenges with this issue. I pray that God will give you the courage, and favor with the stakeholders of this project, to make wise decisions.
