**Subject:** CEC record-Docket #11-AFC-03 Quail Brush Power Generation Siting Case.

Dear Local and State government representatives,

Some of the best memories of my childhood include exploring Mission Trails park with my father. I was 6 years old the first time I remember hiking there with him, in 1981. The thought of this beautiful piece of natural land and historic Native American Site being destroyed for a power plant enrages me. So many places around San Diego I remember as a child have now been built up, covered with houses and business parks. Please leave this natural treasure as it is, for future generations to explore.

I remember the first time I explored Mission Trails with my dad and, who then lived in Del Cerro. I was staying with him in his condo, after my parents divorced. I lived in Tierrasanta with my mom and sister. I have so few happy memories of my father. Please don't take this special place away from all the other San Diego locals who share memories of this precious park. And Don't take it from the native tribe that used to call this land home.

Please add me to the list of concerned citizens who oppose the proposed Quail Brush Generation Plant on the grounds that the proposal is a poor use of the land.

The proposed QBGP is inconsistent with many of the City of San Diego's laws, ordinances, regulations, and standards (LORS). The project conflicts with: the East Elliott Community Plan, which designates the site as Open Space; the General Plan, which designates the site as Park, Open Space, and Recreation; and the Municipal Code, which designates the site's zoning as single-family residential (RS-1-8).

The proponents of the plant must obtain a community plan amendment, general plan amendment, and rezone from the City of San Diego. The proposed project is also located within the City's Multi-Species Conservation Program (MSCP) Subarea Plan, with which it is incompatible. To make the project consistent with the Subarea Plan, the applicant would need to obtain from the City a boundary line adjustment of the Multi-Habitat Planning Area to exclude the project site.

The Taxpayers of San Diego County object to any further spending of California taxpayer dollars in pursuit of a project that violates so many key local land use provisions.

Additionally the power plant siting threatens the well-being, health, recreation, natural beauty, quiet, property value and quality of life of all San Diego county residents who use Mission Trails park or who live in the areas of Navajo, Tierrasanta and Santee due to the proximity to parks and residences.

We urge the CEC to implement the No Project Alternative.
