On June 15, 2012, the Committee assigned to the above-referenced proceeding issued its Notice of Prehearing Conference and Evidentiary Hearing and related Schedule ("Notice and Scheduling Order"), which set forth the time by which all parties must docket and serve their respective evidence and supporting testimony for purposes of the Evidentiary Hearing scheduled for July 23, 2012.
