On June 25, 2012, the California Energy Commission received a petition from Palen Solar I, LLC requesting approval to transfer the ownership of the Palen Solar Project, from Palen Solar I, LLC to Nalep Solar Project I, LLC, a wholly owned, indirect subsidiary of BrightSource Energy, Inc.

The 500-megawatt project was certified on December 15, 2010, and construction activities have not commended. The project site is located approximately 0.5 miles north of U.S. Interstate-10 (I-10), approximately 35 miles west of Blythe and approximately 10 miles east of Desert Center, in an unincorporated area of eastern Riverside County, California.

ENERGY COMMISSION REVIEW PROCEDURES

A statement describing the change in ownership, signed under penalty of perjury by a representative of the proposed new owner of the project, was submitted to the Energy Commission for review and approval as required by Title 20, California Code of Regulations, section 1769(b). The statement included (A) a discussion of any significant changes in the operational relationship between the owner and operator; (B) a statement identifying the party responsible for compliance with the commission's conditions of certification; and (C) a statement verified by the new owner or operator that the new owner or operator understands the conditions of certification and agrees to comply with those conditions. Based on the information provided, staff intends to recommend the proposed change of ownership be approved by the Energy Commission at the July 11, 2012 business meeting and that the approval should be effective on the date that the sale of the project to the new owner closes.
