On June 25, 2012, the California Energy Commission (Energy Commission) received a petition from Palo Verde Solar I, LLC requesting approval to transfer the ownership of the Blythe Solar Power Project (BSPP), from Palo Verde Solar I, LLC to NextEra Blythe Energy Center LLC.

The 1,000-megawatt project was certified on September 15, 2010, and construction was initiated in November 2010. The facility will be located approximately eight miles west of the City of Blythe and two miles north of the Interstate-10 freeway on land managed by the Bureau of Land Management (BLM) in Riverside County, California.

**ENERGY COMMISSION REVIEW PROCEDURES**

A statement describing the change in ownership, signed under penalty of perjury by a representative of the proposed new owner of the project, was submitted to the Energy Commission for review and approval as required by Title 20, California Code of Regulations, section 1769(b). The statement included (A) a discussion of any significant changes in the operational relationship between the owner and operator; (B) a statement identifying the party responsible for compliance with the commission's conditions of certification; and (C) a statement verified by the new owner or operator that the new owner or operator understands the conditions of certification and agrees to comply with those conditions. Based on the information provided, staff intends to recommend the proposed change of ownership be approved by the Energy Commission at the July 11, 2012 business meeting and that the approval should be effective on the date that the sale of the project to the new owner closes.


