
I, Dorian S. Houser, pursuant to the Committee Scheduling Order posted March 05, 2012 file this status report to the Committee.

Ongoing Discovery

The Applicant filed objections to data requests 1, 2, 3, 6, 8, 9, 10, 12, 13, 14, 15, 16, 17, 18, 19, 22, 23 and 27 and was unable to provide responses to data requests 21, 24, 25 and 26 within the response period required following receipt of the data request. As part of the discovery process, I have continued to review responses to Staff and Intervenor data requests provided by the Applicant. I have studied air quality modeling, including EPA regulations and recommendations, and the CEQA process in relation to the original and supplemental documents provided by the Applicant. I have engaged and attempted to engage academic and EPA experts on air quality modeling with particular respect to the procedures utilized by the Applicant. I continue to prepare requests for additional information based on Applicant responses to all Staff and Intervenor data requests and intend to have them filed before the end of August.


