**TWENTY-FOURTH STATUS REPORT OF
GENON WILLOW PASS, LLC**

In accordance with the Committee Scheduling Order dated December 31, 2008, the applicant in this proceeding, GenOn Willow Pass, LLC (“GenOn Willow Pass”), submits its twenty-fourth status report in this proceeding. GenOn Willow Pass is seeking certification for the Willow Pass Generating Station, a 550 megawatt, natural gas-fired electricity generating facility to be located in Pittsburg, California.

There are no updates to report at this time. As reported in previous status reports, GenOn Willow Pass has received approval from Commission staff for the *Work Plan for Focused Site Investigation and Focused Health Risk Assessment* that was prepared by a consultant to Pacific Gas and Electric Company (“PG&E”), the former owner of the project site, in response to staff’s Data Requests 73 through 75. The work plan provides for collection of soil vapor and groundwater samples and preparation of a focused Health Risk Assessment that includes a Human Health Risk Assessment and a Screening Level Ecological Risk Assessment (“HRA”). GenOn Willow Pass intends to work with PG&E to conduct the sampling and prepare the HRA for submission to staff.
