Project Title: Adoption of Revisions to the *Energy Efficiency and Conservation Block Grant Program Guidelines*.

Description of Nature, Purpose, and Beneficiaries of Project: The purpose of this activity is to revise guidelines previously adopted by the California Energy Commission to govern the administration of its Energy Efficiency and Conservation Block Grant Program (EECBG) pursuant to Public Resources Code Sections 25450 – 25450.5. The EECBG is funded through a grant from the U.S. Department of Energy with moneys from the American Recovery and Reinvestment Act of 2009 (ARRA). The EECBG guidelines describe how the Energy Commission will implement the EECBG and identify available funding, eligibility criteria, the evaluation and award process, and other requirements to qualify for funding under the program. The guidelines were revised to 1) extend the deadline for completing EECBG-funded projects from September 13, 2012, to September 13, 2013, and 2) remove references in the guidelines to the California Energy Commission's ARRA Ad Hoc Committee, which no longer exists, and replace them with references to the Executive Director, which is now authorized to carry out certain activities as specified in the guidelines. The California Energy Commission and participants of the EECBG benefit from the adoption of revisions to these guidelines.
