**Subject:** El Segundo Energy Center Complaint: Agreement to waive 30 day hearing requirement

Hearing Officer Kramer:

El Segundo Energy Center, LLC and the Complainants, Michelle Murphy and Robert Perkins have agreed to waive the requirement in 20 CCR §1237 that the Commission must act to hear the complaint within 30 days of the staff report. They have agreed that complaint can be heard on the regularly scheduled business meeting date of September 12. Doing so allows the State of California and the Commission to avoid the expense and

inconvenience of a special meeting for this complaint, and allows the parties additional time to attempt to resolve outstanding issues.

While there are other interested parties, who are CCed on this email, including parties who have petitioned to intervene in the complaint, I believe that the Complaining party and the project owner should have the ability to waive this requirement and allow the Commission to decide to move the hearing of the Complaint to the September 12 business meeting.
