Dear Commissioner Peterman:

I am writing to urge you to support continued funding for propane vehicle incentives through the Alternative and Renewable Fuel and Vehicle Technology Program (ARFVT Program). This program has helped A-Z Bus Sales, Inc. reduce emissions, lower our dependence on foreign oil and save money through lower fuel costs by replacing over 465 Blue Bird, Micro Bird & Collins Bus School buses to run on propane autogas.

A-Z Bus Sales, Inc. is an Employee Owned Corporation that has been in the business of selling buses for over 30 years. We have approx. 140 employees with two facilities, one in Southern and one in Northern California. Our experienced sales staff covers territories throughout the State of California.
