#### **Purpose of Status Conference**

This status conference is held by the Committee for the primary purpose of informing the committee, the parties, and the public about the project's progress to date in the AFC process. **The Committee requests that the parties submit status reports by October 15, 2012 and be prepared to discuss the impact of the City of San Diego's September 24, 2012 decision concerning initiation of a zoning change requested by the applicant. In particular the Committee would like to discuss with the parties the requirement that the Committee consider 1) whether the project is required for the public convenience and necessity and 2) whether there is not a more prudent and feasible means of achieving public convenience and necessity (override findings) in compliance with section 25525 of the Warren-Alquist Act. Timely submission of status reports will assist the committee in addressing the parties' concerns during the status conference.**

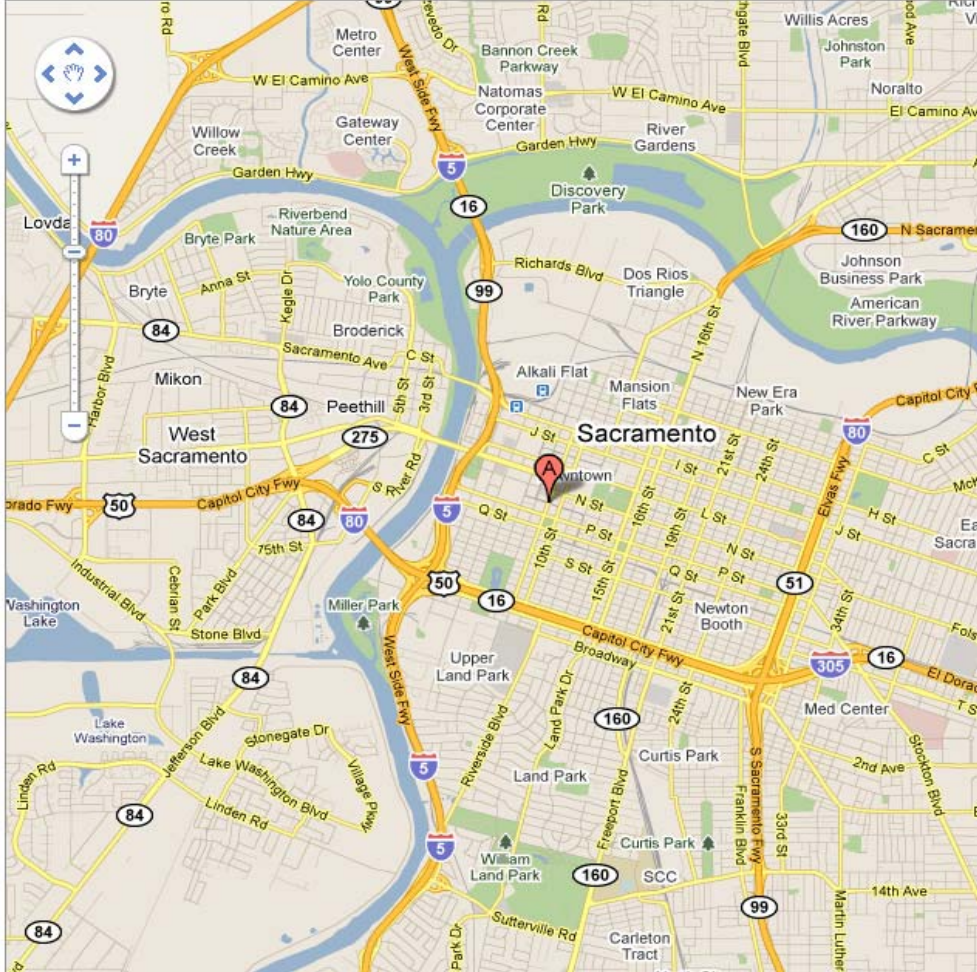
