K Road Calico Solar Project Amendment (08-AFC-13C)

On October 2, the 2012, the California Energy Commission issued a Revised Committee Scheduling Order for the K Road Calico Solar Project requiring submittal of monthly status reports beginning on October 10, 2012 and continuing on the 10th of each month thereafter. This letter is to serve as a status report as indicated therein.

Since the time of filing the Petition, K Road has and is currently working on transmission issues related to the CAISO that affect the timing of the Project and could result in possible modifications to the Large Generator Interconnection Agreement (LGIA).

As indicated in the previous letter, K Road believes that the transmission issues, when resolved, will not modify the current layout of the Project, which we believe further minimizes any environmental impacts of the Project. K Road is still focusing efforts on resolving the transmission issues at this time.

K Road is diligently working to resolve the issues and provide the information required for the CEC for further evaluation.
