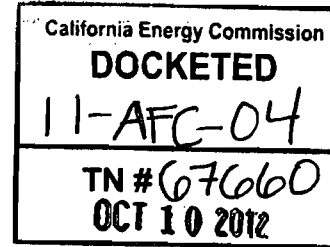

Pursuant to Section 2505(a)(4), Title 20 of the California Code of Regulations, Rio Mesa Solar I, LLC and Rio Mesa Solar II, LLC (collectively, the "Applicant"), hereby submits this "Repeated Application for Confidential Designation" for certain paleontological resources information for the Rio Mesa Solar Electric Generating Facility.
