QUAIL BRUSH GENERATION PROJECT (11-AFC-3), STAFF'S STATUS **REPORT #6**

Per the Committee's Revised Scheduling Order dated October 2, 2012, staff hereby submits its Status Report #6 regarding the proposed Quail Brush Generation Project (QBGP).

Ongoing Discovery

Staff is continuing to review the Application for Certification (AFC) and subsequent filings, including Supplement 3 to the AFC. Staff is also continuing to conduct discovery to further its analysis of the proposed QBGP. Since staff filed its last status report on August 15, 2012, staff has issued additional data requests, held one workshop and will hold an additional workshop on Friday, October 19, 2012.

The applicant has continued to file responses to staff's data requests. The applicant is expected to file additional data responses during the next 30-days. The applicant has advised staff that the applicant will likely file, by October 31, 2012, a proposed mitigation package related to air quality, an updated Biological Survey Report; and information regarding fire protection needs.

City of San Diego's Recent Action

On September 24, 2012, San Diego's City Council denied the applicant's request for the city to accept and review the QBGP's application to amend the East Elliot Community Plan. The result of that action is the community plan designation and zoning for the project site will be inconsistent with the proposed power plant unless the city were to change its position and consider the plan amendment. Inconsistency with the community plan and zoning means the Energy Commission could approve the proposed QBGP only if it made the findings to override the inconsistency as described in the Committee's October 2 order.

Staff continues to coordinate its review of the AFC with the City of San Diego's staff. This coordination is intended to ensure that all aspects of the proposed project are evaluated by Energy Commission staff for compliance with laws, ordinances, regulations and standards (LORS), and to obtain any analysis, comments, and

recommendations the City may have regarding the QBGP (Cal. Code Regs., tit. 20, §§ 1714, subd. (c), and 1744).

Future Staff Workshops

Staff is planning to hold its next workshop on Friday, October 19th, 2012, in the city of El Cajon which is adjacent to the city of Santee. The workshop will include discussions on biological resources, fire protection, noise, soil & water resources, and visual resources. Staff expects the discussions on each topic will focus on potential impacts and proposed mitigation measures. Staff will hold additional workshops, as necessary.

Schedule

Staff has no objections to the Committee's Revised Schedule. As staff gathers more information from other agencies, staff will inform the Committee of tentative dates for the review and possible permitting by those respective agencies¹. At this time, staff doesn't expect the timing of the review by other agencies to affect the Committee's revised schedule.
