IN A LETTER FROM GALATI/BLEK LLP DOCKETED 09-AFC-6C TIN# 66964 AUG 28 2012 TO THE CALIFORNIA ENERGY COMMISSION, ON PAGE 2 THEY SAY THE EASTERN BOUNDARY AND WESTERN BOUNDARY WILL BE MOVED, BUT NO MENTION OF NORTH OR SOUTH BUT THEY MOST CERTAINLY DID JUST THE OPPOSITE. I ALSO HAVE A LETTER FROM IAN BLACK (SOLAR DEVELOPMENT ENXO-AN EDF ENERGIES NOUVELLES COMPANY DOCKET 09-AFC-6 JULY 13 2010) WHICH I FOUND INTERESTING, JUST HOW IS NEXTERA GOING TO GAIN INGRESS EGRESS ALONG WITH AMPLE TRANSMISSION LINES TO SERVICE BOTH PROJECTS AND STILL LEAVE FUTURE PROJECTS WITH THE SAME?




