Mr. Porter,

I was reviewing your letter and wanted to correct a few things as you mentioned my name specifically in the letter. The option agreement that was going to expire was with the previous owner/entity and a new option agreement and amount was negotiated and agreed upon and executed by you and Mrs. Porter with Next Era Energy (awaiting Next Era signature and your 1099 information).

When you were asked to fill out a 1099 and refused, and that you were not interested in going any further unless Next Era upped the amount you would have to pay in taxes. It was explained that no payments to anyone could be sent from the AP system of Next Era unless the 1099 was complete for federal income tax reporting purposes.

Next Era declined to up the dollar amount after the agreement was executed by you and subsequently decided to let the previous option agreement expire. It was explained to me that there were a number of unknowns with the project and it's potential layout that were many months away from being determined.
