My name is Satish Kuar and I am on Technical side handles new product development and certifications.

We would like to comment on CEC quality LED lamp specifications draft are participant do programs with the help of utility and Energy star standards as our criteria.

Greenlite 1<sup>st</sup> Energy star product line roll out G1( generation 1) was in 2011 May, G2 was in 2012 ( jan to sep) and now we are launching G3 energy star approved product line in 1<sup>st</sup> quarter next year.

If we follow your specs for example PF>0.90, CRI>90 then we need to redesign full product line, re send these lamps for safety testing (UL, ETL etc...), re send for Energy star testing (6-7months) which is going to cost us minimum of \$150,000 plus along with months of uncertainty on what product is conforming to which standard creating confusion in the market place.

We suggest to follow Energy star standard and establish a time line to create a standard which will be premium and above current Energy star standard.

We think that new std would effect the current momentum in market penetration of LED products.
