STATUS REPORT #18 FOR THE SUN VALLEY ENERGY PROJECT (05-AFC-3)

Dear Mr. Worl,

Pursuant to the terms of the Commission's Order Suspending Proceeding dated June 20, 2012, Valle Del Sol Energy, LLC submits Status Report #18 for the Sun Valley Energy Project. The Sun Valley Energy Project (SVEP) is a 500-megawatt natural gas-fired peaker plant that will be located in the City of Menifee, California. The site is located on 50 acres of former farm land 30 yards southwest of the Valley Substation and will feature five General Electric LMS-100 gas turbines.

As stated in previous status reports, we have demonstrated ownership of all required VOC ERCs. However, we continue to monitor the PM_{10} and SO_x ERC shortage that is affecting the entire SCAQMD region and is preventing us from completing the AQMD and CEC permitting and licensing necessary for the project to advance. As stated previously, the Walnut Creek Energy Park recently found a solution to allow the Walnut Creek project to meet District requirements and proceed to construction. Replacing Huntington Beach Units 3 and 4 with Walnut Creek will provide air quality and reliability benefits to Southern California. Similarly, the SVEP would like to be a part of the transition to more efficient and reliable operation for Southern California.

Recently, Southern California Edison issued a transmission system reassessment report to reflect withdrawal of generation projects ahead of the SVEP in the interconnection queue and import assumptions used by CAISO for interconnection studies. Valle Del Sol has received this report and it is currently under review.

We will continue to work toward a solution that will allow the SVEP to proceed.
