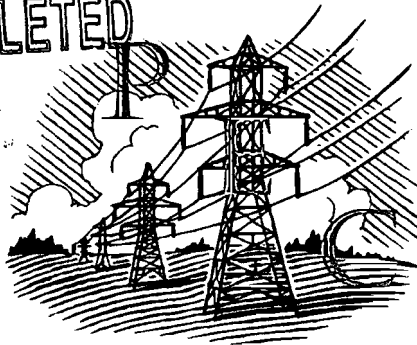

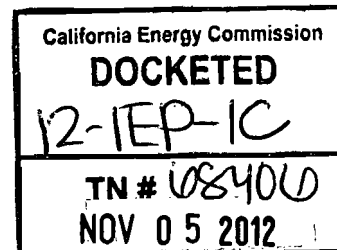


Disclosure with aggregated data is permissible as long as the Plant is not identified.
