STATUS REPORT #20 FOR THE SUN VALLEY ENERGY PROJECT (05-AFC-3)

Dear Mr. Worl,

Pursuant to the terms of the Commission's Order Suspending Proceeding dated June 20, 2012, Valle Del Sol Energy, LLC submits Status Report #20 for the Sun Valley Energy Project. The Sun Valley Energy Project (SVEP) is a 500-megawatt natural gas-fired peaker plant that will be located in the City of Menifee, California. The site is located on 50 acres of former farm land 30 yards southwest of the Valley Substation and will feature five General Electric LMS-100 gas turbines.

As previously mentioned, Valle Del Sol received and has now reviewed the transmission system reassessment report from Southern California Edison. The report, which reflects the withdrawal of generation projects ahead of the SVEP in the interconnection queue and important assumptions used by CAISO for interconnection studies, indicates that minor terminal upgrades and a special protection system (SPS) will be required if the SVEP is in-service prior to the completion of the West-of-Devers transmission upgrade. We plan to execute the Facility Re-Study Agreement so that SCE can perform the facility study.

We continue to monitor the ERC shortage in the SCAQMD region which is preventing us from completing the AQMD and CEC permitting and licensing necessary for the project to advance. Valle Del Sol would like to be a part of the transition to more efficient and reliable operation for Southern California.
