ENERGY COMMISSION STAFF COMMENTS ON OLD SPANISH TRAIL ASSOCIATION MOTION FOR SUBPOENA DUCES TECUM

Intervenor Old Spanish Trail Association (OSTA) has filed a motion for subpoena for various data pertaining to surveys seeking traces of the Old Spanish Trail on the project site. Several of the documents sought (set forth in the first item of the motion) are items already submitted to the Energy Commission, and are either available as public records, or subject to confidentiality designations pursuant to the California Public Records Act. To the extent the motion seeks items that are already docketed with the Commission as public records, the OSTA motion is an inappropriate discovery mechanism.

OSTA lists on page 2 of its motion the kind of information that it seeks, particularly with regard to the cultural resources survey that surveyed for evidence of the Old Spanish Trail on the project site. Staff understands that the survey concluded that there were no trail traces; if there were not, there are no "sites" that could be imperiled by release of those portions of the cultural resources survey that pertain to the trail, including survey techniques and conditions, and instructions for the consultants, for the Old Spanish Trail. If this is correct, there is no apparent reason why OSTA should not have access to that information in the cultural resources report.

OSTA might attempt to acquire such information by filing a petition with the Energy Commission Chief Counsel pursuant to the Commission's regulations, requesting that the parts of the cultural resource survey pertaining to the Old Spanish Trail be released, either in subpart or in a redacted version that removed any location information about other cultural resources. (Cal. Code Regs., tit. 20, § 2506, subd. (a).) This, of course, would require action by the agency and may take time. Alternatively, Brightsource could simply provide that portion of the consultant's report pertaining to the trail survey, redacting or withholding any sensitive information pertaining to artifacts or site locations. This might at least partly resolve this discovery issue raised at this every late date in the process.
