PREHEARING CONFERENCE STATEMENT OF INTERVENOR OLD SPANISH TRAIL ASSOCIATION

Intervenor Old Spanish Trail Association ("OSTA") hereby submits its Prehearing Conference Statement pursuant to the Prehearing Conference and Evidentiary Hearing and Order ("Order") in the Matter of Application for Certification of the Hidden Hills Solar Energy Generating System ("HHSEGS", or "Project").

The Order identifies nine items [labeled a) through i)]. OSTA responds to each of these as follows:

a) The subject areas that are complete and ready to proceed to Evidentiary Hearing: The Cultural Resources area, in particular issues regarding the Old Spanish National Historic Trail/Mormon Road Northern Corridor ("OSNHT/MR NC"), is ready to proceed to Evidentiary Hearing with the sole exception of documents and writings relating to Brightsource's pedestrian survey of the project site. OSTA has previously requested these documents and writings, but BrightSource has continuously refused production. The specific documents, their relevancy and necessity for production are set forth in OSTA's pending Motions for Subpoena Duces Tecum and to Strike..., previously filed on February 18, 2013 ("Motions"). These Motions seek production of documents and writings, as described therein, relating to Applicant Brightsource's pedestrian survey of the project site.

- b) The subject areas that are not complete or ready to proceed to Evidentiary Hearing: There are no Cultural Resources areas that are not complete or not ready to proceed to Evidentiary Hearing, again with the sole exception of the documents and writing described above in item a), which are the subject of OSTA's pending Motions.
- c) The subject areas within Cultural Resources that remain disputed and require adjudication, and the precise nature of the dispute for each of these areas. The areas in dispute between OSTA and the BrightSource, as represented in the area of Cultural Resources by the consultant firm CH2MHill, are as follows:
 - 1. Whether segments of the OSNHT/MR NC, and sites associated with its use, are within the Project boundaries. Whether the grading and earth movement of the site and construction of the generation plant will permanently destroy this portion of the Trail Corridor and will have indirect impacts to cultural resources just outside the Project boundaries. For example, whether the large work force involved in construction is likely to place pressure on the Stump Springs Area of Critical Environmental Concern. Also, whether the Project, with its twin 750-foot towers will dramatically impact the visual resources of the Pahrump Valley and the ability to vicariously enjoy the experience of the OSNHT/MR NC.
 - 2. Whether, despite CH2MHill's assertion that an archaeological pedestrian survey of the entire Project site performed in 2011 and a later study entitled "Historic Trails and Roads Technical Study" [CONFIDENTIAL Attachment DR125, March 30, 2012], it can be concluded that there is no relevant evidence of portions of the OSNHT/MR NC remaining on the Project site. [NOTE: OSTA cannot properly assess BrightSource's claim without access to the research methods and findings of the 2011 pedestrian survey. On February 18, 2013, OSTA filed the Motions seeking documents from BrightSource/CH2MHill that would allow OSTA to assess the validity of BrightSource's claims regarding the 2011 pedestrian survey.]

In contrast to BrightSource's claims, archaeological pedestrian surveys conducted in 2010, 2011, and 2012 by OSTA have recorded segments of the trace on the Project site, with photographic and GPS recordation of these segments. In addition, OSTA has recorded segments of mule trace in the Pahrump Valley southwest of HHSEGS leading from the Project site.

- 3. Whether under all relevant facts BrightSource's characterization of provisions of the National Register of Historic Places is correct. (See, Applicant's Opening Testimony ("AOT"), pp. 11-12.) For instance, there is no NRHP requirement that the Trail be part of the route mapped by Fremont (AOT, p. 12). Using such a characterization BrightSource concludes that NRHP criteria do not apply to segments that may fall within the Project site. In connection with its characterization, whether, BrightSource can continue to ignore or must it acknowledge the existence and significance of the provisions of the National Trails System Act and U.S. Federal Standards for National Historic Trails (OSTA Exhibit 623, herein).
- 4. Whether BrightSource can continue to obfuscate, delay and refuse to cooperate and work with OSTA to compare observational data, review archival sources and/or attempt to reconcile their wide differences in interpretation. For example, CH2MHill made one attempt to contact OSTA directly, shown in the list of Consultation Letters to Local Historical Societies (Application for Certification, Vol. 2, Appendix 5-3A,) reveals that their letter was mailed mistakenly to Las Vegas, NV, rather than Las Vegas, NM, where the Association Manager maintains a P.O. Box. BrightSource made no further attempt to contact OSTA directly, even though OSTA maintains a highly visible web site.
- 5. Whether BrightSource's contention (AOT, p.38) that mitigation measure CUL-9, recommended in the CEC Staff's Final Staff Assessment, should be deleted in its entirety, or, as OSTA contends, expanded and customized to repair the great damages which will be caused if the Project proceeds. Since OSTA has produced evidence to show that the Project will impact the OSNHT/MR NC, it is axiomatic that mitigations are required to attempt to offset the damage to Trail resources should the Project proceed. OSTA asserts that mitigation measures stronger than those proposed in the FSA are required for CUL-9.
- 6. The argument above, relating to CUL-9, applies to CUL-10. OSTA also asserts that stronger mitigation measures are required for CUL-10, to ensure that the Trail resources lost forever will live on as part of an innovative, appropriate interpretive and educational plan.

d) Identity of OSTA witnesses and summary of testimony

Name: Jack Prichett

- Subject area: Part I: Old Spanish National Historic Trail route, protection under Federal law and standards, relationship to the HHSEGS site; Part II: Deficiencies of CUL-9 as written in CEC's FSA and proposed changes to strengthen the mitigation.
- Summary of Testimony: Part I of Mr. Prichett's testimony will address the archival and archaeological evidence that the HHSEGS project will impact portions of the OSNHT/MR NC and will demonstrate the applicability of the National Trails System Act and the Federal supporting Trail Standards. Part II of his testimony will address the need for more complete data recovery to bolster mitigation measure CUL-9, as it is articulated in the CEC's Final Staff Assessment.

Qualifications: PhD training in anthropology at Univ. of California, Berkeley; Former historical archaeologist in the San Francisco bay area; five years of archival research and site survey on segments of OSNHT/MR NC adjacent to the HHSEGS site and Stump Springs.

Name: Elizabeth van Till Warren, PhD

Subject area: Historical significance of the Old Spanish National Historic Trail

- Summary of Testimony: Dr. Warren will testify as to the criteria guiding the establishment of National Historic Trails; the special recognition they receive under Federal government statute and management; and some of the historical personages and events along Mojave portions of the Trail.
- Qualifications: Ph. D. in American history, specializing in Old Spanish Trail history and 19th and 20th Nevada history. Her M.A. thesis topic examined the route followed by Antonio Armijo, who led the first mule caravan from Santa Fe to Los Angeles.

Subject area: Mobile museums, interpretive information, exhibitions and displays

Summary of Testimony: Mr. Bent will testify to deficiencies of the FSA's mitigation measure CUL-10, which delineates proposed development of displays and interpretive materials. He will explain proposed changes to strengthen the mitigation and provide the rationale for the broader scope.

Qualifications: 30 years experience in trade shows, exhibitions. For 25 years, he was manager of trade shows and exhibitions, then marketing communications, for Northrop Grumman, a Fortune 100 company.

Subject area: History of the Mormon Road

- Summary of Testimony: Mr. Sutak will testify to the well-documented history of the Mormon Road and its significance to southern California and Southwestern U.S. history. As a scholar of Mormon history, Mr. Sutak has done extensive archival research on the OSNHT/MR NC. He possesses detailed knowledge of archival accounts of those who traveled the trail, including descriptions of the Stump/Hidden Hills/Rocher qui pleu area.
- Qualifications: Trained researcher and published author on Mormon history. His book, *Into the Jaws of Hell*, a biography of Mormon leader Jefferson Hunt, was published in early 2012. Hunt traveled over the OST.

Name: Susan Sorrells

- Subject area: Importance of cultural resources and unspoiled desert environment to businesses in the Pahrump/Tecopa/Shoshone area. She speaks as a lifelong resident of the Shoshone, CA/Pahrump, NV area who wishes to see the local environment protected from industrial development.
- Summary of Testimony: Will express her opposition to licensing the HHSEGS plant and her support for the position of the Old Spanish Trail Association. Her business, and others, depends on tourists attracted to the wild desert environment and local history—the old mines, the Old Spanish Trail, and ghost towns.
- Qualifications: More than 30 years of experience as a business owner in Shoshone and a lifelong attachment to this part of California, in which I was raised. Ms. Sorrells was a founder of the Shoshone Museum, a venue mentioned in the FSA as a possible location for displays and interpretive materials specified in CUL-10.

h) Proposals for briefing deadlines, impact of scheduling conflicts, or other scheduling matters

OSTA notes, as it did in **Section f) Exhibits**, that it may receive additional documents from BrightSource or its consultant CH2MHill as a response to OSTA's motion for a Subpoena Duces Tecum that was filed on February 18, 2013. These documents may become, in whole or in part, exhibits, which OSTA may introduce into evidence. This is not expected to affect scheduling.

i) Description of any proposed modifications to the proposed conditions of certification listed in the Final Staff Assessment based upon...consistency with the evidence

OSTA, in its opening testimony, describes proposed modifications to mitigations measures CUL-9 and CUL-10. OSTA's modifications are intended to make the mitigations more commensurate with the impacts to the OSNHT/MR NC, as described in the FSA.

In the FSA, CEC staff concluded: The project would significantly impact the OST-MRNC by erasing potential tracks and traces onsite...Destruction of the tracks and traces, and the resulting loss of integrity, is irreversible. Staff has concluded that this impact on the **informational values of the OST-MRNC is significant** and must be mitigated." (CEC FSA, p 4.3-116; Emphasis added.)

In addition, CEC staff concluded with respect to Visual Resources: "The integrity of the setting, feeling, and association of the tracks and traces outside of the HHSEGS project site would thus be significantly impacted by the project...(FSA, p. 4.3-116). As the FSA notes these impacts will apply to National Register-listed sections of the OSNHT/MR NC in Nevada. It would also impact segments of the mule trace visible from the low ridge separating the Pahrump and California valleys.
